## RESOLUTION NO. 27 OF 2025 AUTHORIZING APPROVAL OF CHANGE ORDERS TO THE CONTRACT FOR THE BUILD-OUT OF A NEW ANIMAL SHELTER LOCATED AT 427 BEACH ROAD IN HAVERSTRAW, NY

**Phillips:** Mr. Executive Director, could you state what we are doing here with this change order.

**Damiani:** Thank you Mr. Chairman. This resolution is associated with the build-out of RG Cares Animal Shelter. Change Order 2 in the amount of \$94,178.70 for excavation and installation of a 612 linear feet of six-inch HDPE drainpipe and the removal and reinstallation of new rigid insulation board along the existing wall and connecting to a twelve-inch HDPE storm pipe. The original change order came in at \$107,292.10 and we were able to negotiate 12% savings. Change Order 5 in the amount of \$14,792.40 to restore the foundation wall at the South exterior side including doweling and installing epoxy and installing #4 rebar into the existing rebar matting to support the large concrete slab. Total change order increase to the contract amount \$108,971.10 and the amended contract price to \$14,904,277.24.

### RESOLUTION NO. 28 OF 2025 ACCEPTING PROPOSAL AND AWARDING CONTRACT FOR THE RENOVATIONS OF ROCKLAND GREEN ADMINISTRATIVE HEADQUARTERS AND CONSTRUCTION OF AN IMMERSIVE THEATER EXPERIENCE

**Phillips:** I think most of the members know we used to have a wonderful theater that students throughout Rockland County could go to. They went to Torne Valley and saw great demonstrations. What we are trying to do is recreate that at our new location and we are doing some major renovations. Once again, I think all of us agree that we can capture school age children to learn about recycling and they will get their parents to recycle. It is very important.

**Damiani:** Rockland Green is seeking authorization to award RFP-2025-02 to Pierotti Corp. in the amount of \$4,385.400 to facilitate substantial modifications to the Rockland Green Administrative Offices. These enhancements will enable the installation of the Rockland experience immersive theater experience with interactive hands-on exhibits and environmental arcade games to support solid waste education and outreach and improving a minimum the following; the exterior, installing a first floor

lobby, an entrance with an ADA ramp, painting the exterior brick façade, new emergency exit ramp on the North side of the building, new nine-inch by thirty-two digital sign to promote programs and events, installation of new emergency generator, on the first floor new lighting, new ADA accessible restroom, miscellaneous doors and matching hardware, new interior finishes, flooring, walls, and ceilings, installation of sound absorbing material, new fire alarm panel and associated heat and smoke heads, and new kitchenette. On the second floor, new conference room, two new offices, new lighting, new interior finishes, floor, walls and ceiling, new kitchenette, complete roof replacement. The roof is over 5,500 square feet with new curbing, new HVAC equipment consisting of one dedicated outside area unit with two VRF's to supply heat and cooling capacity to support over sixteen indoor ceiling cassette units in compliance with the EPA's final ruling and New York State DEC refrigerant use of R32 in lieu of R410A refrigerant. A new solar panel system installed on the roof to achieve a 46% annual billing offset of electrical use. There were seven addendums issued during the procurement where we received two proposers Key Construction Services and Pierotti Corp. The original price came in from Key Construction Services at over \$5.2 million. Their best and final offer was \$4,586,146. Pierotti Corp. initially submitted an original price of \$5,169,400 and their best and final offer was \$4,526,400. The team went back to Pierotti Corp. to get additional clarifications, and they resubmitted on July 21, 2025 in the amount of \$4,385,400.

**Monaghan:** Executive Director, listening to what you are saying, there is major roof and air conditioning that has to be done for this building. All this work has to be done?

Damiani: Correct.

Monaghan: With just the immerse theater experience, what is the ballpark of that cost?

**Damiani:** That is a separate contract at about \$580,000.

**Monaghan:** My concern is it is something we need to educate the students. When I saw the price that high, we are spending that much. My concern thinking the theater, that is a reasonable price for that type of work for that theater?

Damiani: Yes.

**Phillips:** Just to inform everyone, the attempt here is not to bond for this. The intent is to take it out of our surplus.

Damiani: Correct.

**Phillips:** That is one of the reasons why we build that fund up is so that we can offset the cost to the taxpayers. We have been very successful with grants also which really makes a big difference, and the revenue comes in especially when we take municipality's from out of County. We have a number of ways that we build up the unrestrictive reserve, so we might as well use that money. I think we are at about \$36 million.

Damiani: Yes; \$36 million.

### 8. New Business

**Phillips:** Mr. Executive Director, is there any new business?

**Damiani:** Yes. For RG Cares we have two additional change orders that we completed the negotiations today. Change Order 1 in the amount of \$69,371.85 for the removal and hauling of additional concrete and soil and the importation and compaction of additional six inches of type 2 subbase. The original change order came in at \$124,423.12 and the team was able to negotiate down to \$69,371.85. Change Order 8 in the amount of \$2,626.05 for repairing five existing manholes penetrations that were not properly infilled when we purchased the property. The original change order was \$9,388.05 and we negotiated down to \$2,626.05. The total change order increases the contract amount by \$71,997.90 and amends the contract price to \$14,976,275.14.
