As we look to achieve substantial completion, we asked them to recharge the system and that is why a change order is required.

**WHEREAS**, EDR, consulting engineers, reviewed the request and determined a replacement will be required; and

**WHEREAS,** lead time to delivery of a Wide Bay Compost Agitator and Dolly from BDP Industries, is sixty (60) weeks or longer; now therefore be it

**RESOLVED**, that Rockland Green approves the purchase of a Wide Bay Compost Agitator and Dolly from BDP Industries, BDP Quote # 092522-2037 REV B; and be it further

**Damiani:** Currently, the facility utilizes two agitators for processing sludge into a reusable compost product. The process relies on forced aeration and mechanical mixing of the feed stock to accelerate the biological process. Based upon the findings in both the EDR memorandum and BDP evaluation report, Rockland Green is requesting authorization to purchase a new agitator in the amount of \$650,500. Lead time on this unit is approximately 60 weeks out. The existing agitator was installed in 2013 and has processed over 600,000 tons of sludge.

### RESOLUTION NO. 45 OF 2023 AUTHORIZING AMENDMENT TO THE HAULING SERVICES AGREEMENT FOR THE CLARKSTOWN TRANSFER STATION BETWEEN ROCKLAND GREEN AND MR. BULT'S INC.

WHEREAS, Rockland Green and Mr. Bult's, Inc. (the "Company") entered into a Hauling Services Agreement for the Clarkstown Transfer Station, dated as of September 1, 2013 (the "Service Agreement") for hauling services from the Clarkstown Transfer Station located in the Town of Clarkstown, New York to the disposal site designated by the Authority therein; and

**WHEREAS**, the Service Agreement provided an initial term of five years plus up to five oneyear renewal terms, exercisable by Rockland Green in its sole discretion, with the renewal term pricing to be determined by the parties; and

**WHEREAS**, the initial term of the Service Agreement expired on August 31, 2018, and prior to the expiration of the extension periods, Rockland Green notified the Company that it was requesting to renew the Service Agreement on an emergency basis for a period not to exceed six months; and

**WHEREAS**, prior to the expiration of the fifth renewal term, Rockland Green and the Company commenced negotiations of renewal term pricing on an emergency basis for a six-month period; and;

**WHEREAS**, the parties have agreed upon the renewal term pricing and related provisions and have included such agreement in the terms of an amendment to the Service Agreement; now therefore be it

**RESOLVED**, that the Executive Director is hereby authorized to enter into an amendment to the Service Agreement substantially in the form presented at this meeting; and be it further

**RESOLVED**, that the Executive Director is authorized and directed to do and cause to be done any and all acts necessary or proper in connection with or for carrying out this resolution; and be it further

**RESOLVED**, that such amendment shall not be binding and valid until executed by the parties.

**Phillips:** Authorizing amendment to the hauling services agreement for the Clarkstown Transfer Station, Mr. Executive Director.

**Damiani:** Authorization to extend the existing hauling agreement with Mr. Bult's Inc. for an additional six months. The contract for hauling services out of West Nyack and long-term disposal are not aligned with one another. Long-term disposal expires August 31, 2024. I can't in good faith issue on RFP if I don't know where I am sending my waste. The six-month extension will allow Rockland Green the ability to negotiate with those proposals received for long-term disposal with Casella and Waste Management to lock in the destination for waste that we send out.
