# Resolution No. 23 of 2016 ADOPTION OF MINUTES, MEETING OF June 2, 2016

**RESOLVED**, that the transcribed Minutes of the Rockland County Solid Waste Management Authority are approved for the meeting June 2, 2016, as recorded by the Clerk and are hereby adopted.

### **Executive Directors Report**

**Roppolo:** As discussed at the last meeting, the Authority continues to review the proposed Part 360 regulations and will be making comments. The regulations have not been revised in twenty years and the revisions are comprehensive. These revisions, as they now stand, will impact all facilities of the Authority. Some significantly. NYSDEC had initially distributed the proposed regulations to all parties in April 2016. Since April the Authority has been reviewing the regulations internally, have had consultants reviewing certain sections and have asked all our facility contractors to indicate any concerns with regard to their obligations as they are currently contractually required to perform. Many industry organizations had requested an extension of the comment period which ends July 15, 2016. Assemblyman Zebrowski had also requested that the comment period to be extended for 60 days in order to perform a thorough review and provide meaningful feedback to the Department. The NYSDEC has extended the comment period to September 13, 2016. The Authority intends to submit comprehensive comments.

Our summer intern, Tom, has reached out to one of our villages to explain the recycling app to their green teams. The presentations he is making to the towns and villages is similar to what he just presented.

At the last meeting there was a discussion regarding use of unrestricted funds and purchase of two pieces of equipment. Under new business, there will be a resolution for your consideration for one of the pieces of equipment the front end loader. This equipment will be used at the Clarkstown transfer station.

According to the Public Authorities Act, each board member is required to complete a "confidential evaluation of board performance" form annually. If you haven't already sent in the evaluation form, please complete it and return it in the self-addressed stamped envelope provided to you at the last meeting. # Resolution No. 24 of 2016 ACCEPTING CAPITAL EQUIPMENT GRANT FROM CARTON COUNCIL OF NORTH AMERICA, INC. FOR RECYCLING OF POST-CONSUMER CARTONS

**WHEREAS,** Carton Council Of North America, Inc. ("CCNA") desires for the Authority to recycle aseptic and gable-top cartons at the recycling facility owned and/or operated by the Authority; and

WHEREAS, CCNA offered a capital equipment grant that would offset the costs of retrofitting the current equipment; and

WHEREAS, notification of award was received by the Authority; so therefore be it

**RESOLVED**, that the Authority Board authorizes the Executive director to enter into an agreement with Carton Council of North America, Inc. in the format attached hereto.

**Roppolo:** The Authority has done a small retrofit to the Materials Recovery facility several months ago. After the retrofit, we had discussed with the Carton Council to include aseptic packaging which is the box like carton food is packaged in.

Stewart: Does that mean the waxy milk cartons?

**Roppolo:** Yes, that's correct. We will have an education campaign in the fall.

Phillips: What is the goal?

**Roppolo:** This originated in Europe where there isn't a lot of glass packaging. The Carton Council wants to give money to the Material Recovery facilities so that they will accept the aseptic material and take it out of the waste stream and the material is sent to the paper mills.

# **RESOLUTION NO. 25 of 2016** AWARD BID FOR THE PURCHASE OF A WHEEL LOADER FOR **CLARKSTOWN SOLID WASTE FACILITY**

WHEREAS, the Authority is under contractual obligation to purchase equipment for use at the Clarkstown Solid Waste Facility located in West Nyack, NY; and

WHEREAS, on June 6, 2016, the Authority issued a Request for Bid, RFB 2016-19 for the purchase of a Wheel Loader; and

WHEREAS, on June 22, 2016 the Authority received a bids from Pine Bush, Jesco, HO Penn and Vantage Equipment in response to the Request for Bid; and

WHEREAS, the Authority staff has reviewed the bids and determined that the bid submitted by Pine Bush Equipment Co., Inc. is in all respects responsive to the Request for Bid and was the lowest responsive and responsible bid, and therefore recommends acceptance of the bid submitted by Pine Bush Equipment Co., Inc.; now therefore be it

RESOLVED, that the bid is hereby awarded to Pine Bush Equipment Co., Inc. for a Komatsu WA500 wheel loader for the amount of \$411,499.00.
