Resolution No. 46 of 2016 ADOPTION OF MINUTES, MEETING OF October 27, 2016

RESOLVED, that the transcribed Minutes of the Rockland County Solid Waste Management Authority are approved for the meeting October 27, 2016, as recorded by the Clerk and are hereby adopted.

Executive Directors Report

Roppolo: As previously discussed, the Authority has met with the various Rockland wastewater treatment plants to finalize the renewal of each Inter-municipal Sludge Management Agreement (ISMAs). Those agreements are on tonight's agenda for your consideration. The previous ISMAs were in place from the inception of the Biosolids composting facility and were up for renewal. The ISMAs will be included in the request for proposals for the operations and maintenance of the Cocomposting Facility due out the first quarter of 2017.

As required by the new audit firm, BST, the audit committee met with the auditors this evening. Fieldwork will commence next month and the audit is slated to begin on February 20, 2017 though to March 3, 2017 with the tentative audit committee meeting schedule for March 8 or 9 of 2017.

The Haverstraw tip floor replacement is complete and operations were back to normal as of Monday November 7.

As discussed at the last meeting, an RFB for a custom scale at the Clarkstown Transfer Station was issued. Responses were received this past Monday and we have a resolution for your consideration to be introduced under new business.

In addition, as previously discussed, the Authority issued a bid for a metering pump station that is to be installed near the Cocomposting Facility to be used as a sampling point for waste water discharge. The resolution is also included on tonight's agenda for your consideration.

The Authority's new carton initiative has begun. Chairman Phillips had mentioned our new initiative on his radio show on WRCR. Postcards describing the initiative have been delivered to the towns, villages, post offices and libraries. Please let us know if you need additional postcards.

As a reminder to the Towns, we will be sending out our Household Hazardous Waste Facility brochures so we must have the shredding dates by mid-December so that the dates can be included in the brochure. Please respond to Kerri with the two dates you would like your shredding events.

Phillips: I am not sure if we responded. Could Kerri give the Towns another call?

Roppolo: Yes.

Phillips: Anna could you state what we are doing with the following agreements?

Roppolo: The agreements with all the wastewater treatment plants just delineates what the responsibility is with each of the plants to deliver the sludge to the Authority. There is no charge to the municipalities. They just have to maintain certain percent solids in the sludge that they bring in.

Resolution No. 52 of 2016 AWARD OF BID FOR INSTALLATION OF A METERING PUMP STATION

WHEREAS, on October 11, 2016, the Authority issued a Request for Bids 2016-32 for the installation of a Metering Pump Station at the Hillburn Transfer Station; and

WHEREAS, Helmer Cronin Construction, Fred Devens Construction, Cal Mart Enterprises, and Montana Construction submitted bids in response to the Request for Bids; and

WHEREAS, the Authority engineers reviewed the bids and determined that the bid submitted by Cal Mart Enterprises conformed to the specifications in the Request for Bids and is the lowest bid; now therefore be it

RESOLVED, that the Authority Board hereby awards the bid for the installation of a Metering Pump Station at the Hillburn Transfer Station, RFB 2016-32, in the amount of \$56,600.00, to Cal Mart Enterprises, and authorizes the Executive Director to execute an agreement for the performance of the work specified in the bid.

Phillips: Can we have an explanation on what we are doing at the pump station?

Heath: As a part of our existing sewer district permit, we are obligated to sample and measure flow for the Cocomposting Facility. We have been doing a compliant flow reading for both the Materials Recovery Facility and the Cocomposting and we are now separating that out in accordance with the permits.

Phillips: So what we are really doing is separating the two out?

Heath: Yes, it really is a flow meter and sampling pump station

Resolution No. 54 of 2016 AWARD OF BID FOR PRURCHASE AND INSTALLATION OF A CUSTOM TRUCK SCALE AT THE CLARKSTOWN TRANSFER STATION

WHEREAS, on October 28, 2016, the Authority issued a Request for Bids 2016-33 for the purchase and installation of a custom truck scale; and

WHEREAS, Advance Scale Company Inc. and Atlantic Scale Company submitted bids in response to the Request for Bids; and

WHEREAS, the Authority engineers reviewed the bids and determined that the bid submitted by Atlantic Scale Company conformed to the specifications in the Request for Bids and is the lowest bid; now therefore be it

RESOLVED, that the Authority Board hereby awards the bid for the purchase and installation of a custom truck scale at the Clarkstown Transfer Station, RFB 2016-33, in the amount of \$60,650.00 to Atlantic Scale Company, and authorizes the Executive Director to execute an agreement for the performance of the work specified in the bid.

Roppolo: The Authority needs to replace the outbound scale at the Clarkstown Facility. Originally we were going to propose to use an off the shelf scale. However, what we had to do for foundation work it would have been costly. The custom scale ended up being less than the original off the shelf scale.

Kohut: Anna, I was wondering how the taking over of the transfer station was doing.

Roppolo: Everything is going very well. We did not miss a beat.
