### AUTHORIZING TEMPORARY EXTENSION AND AMENDMENT OF CONCRETE AND ASPHALT CRUSHING OPERATION OPERATING AND MAINTENANCE AGREEMENT BETWEEN THE ROCKLAND COUNTY SOLID WASTE MANAGEMENT AUTHORITY AND O'SULLIVAN EQUIPMENT, INC.

**WHEREAS**, the Authority and O'Sullivan Equipment, Inc. (the "Company") entered into a Concrete and Asphalt Crushing Operation Operating and Maintenance Agreement, dated as of February 7, 2014 (the "Service Agreement") for the operation and maintenance of the Concrete and Asphalt Crushing Operation located in the Town of Clarkstown, New York; and

WHEREAS, the Service Agreement provided for an initial term of three years plus up to two one-year renewal terms; and

**WHEREAS**, the second renewal term of the Service Agreement expired on February 7, 2019; and

WHEREAS, the Authority and the Company agreed to temporarily amend and extend the Service Agreement (the "Amended Service Agreement") to afford Authority additional time to procure a new agreement; and

WHEREAS, the term of the Amended Service Agreement, is set to expire on March 2, 2020; and

**WHEREAS**, the Authority requires additional time to complete its procurement of a new contract for the Concrete and Asphalt Crushing Operation; and

WHEREAS, the parties have agreed to further extend on a temporary basis the Amended Service Agreement to afford the Authority additional time to complete its procurement of a new contract for the Concrete and Asphalt Crushing Operation; now therefore be it

**RESOLVED**, that the Authority hereby authorizes the execution of an amendment to the Amended Service Agreement to further extend the term to May 31, 2020; and be it further

**RESOLVED**, that the Interim Executive Director of the Authority is hereby authorized to execute the amendment with the Company in a form and on terms and conditions in the best interests of the Authority and not inconsistent with the terms of this resolution; and be it further

**WHEREAS,** on January 3, 2020, the Authority issued a Request for Proposal RFP 2020-01 for Equipment Demolition and Related Work at the Materials Recovery Facility in Hillburn (the "RFP 2020-01"); and

WHEREAS, on February 7, 2020 the Authority received two proposals in response to RFP 2020-01; and

**WHEREAS,** the proposals received in response to the RFP 2020-01 were from OCS Industries, for \$635,918.00 and from Two Brothers Contractors ("TBC"), for \$230,500.00; and

**WHEREAS,** the Authority reviewed the proposals received and determined that the proposal submitted by TBC, conformed to the specifications in the Request for Proposal; now therefore be it

**RESOLVED,** that the Authority Board hereby awards the contract for Equipment Demolition and Related Work at the Materials Recovery Facility in Hillburn, RFP No. 2020-01, in the amount of \$230,500.00, to Two Brothers Contractors, and authorizes the Chairman to execute a draft agreement, for the performance of the work specified in the proposal; and be it further

**RESOLVED,** that the Authority, in its sole discretion, has the right to rescind this award at any time prior to the execution of the contract for the tip floor joint repair at the Clarkstown West Nyack Transfer Station, and such agreement shall not be binding and valid until executed by the parties.

**WHEREAS**, the Authority owns and operates the Clarkstown Yard Waste Composting Facility (including a mulch processing facility) located in West Nyack and operates the New City Yard Waste Composting Facility (also known as the French Farms Facility) located in New City (collectively the "Facilities"); and

**WHEREAS**, the Authority conducted a procurement for (i) the operation of the Facilities, and (ii) the bulk purchase of compost product and mulch product produced at the Facilities; and

**WHEREAS,** on June 6, 2019 the Board approved (i) the operation of the Facilities by WeCare Denali, LLC on an interim basis through December 31, 2019, and (ii) the bulk purchase of compost product and mulch product by WeCare Denali, LLC on an interim basis through December 31, 2019; and

**WHEREAS,** the parties entered into (i) an interim agreement for the operation of the Facilities (the "Interim Operations Agreement"), and (ii) an interim agreement for the bulk purchase of compost product and mulch product (the "Interim Bulk Purchase Agreement"); and

**WEHEREAS,** the Interim Operations Agreement and the Interim Bulk Purchase Agreement both provided for a term to remain in effect through December 31, 2019 and month-to-month thereafter to the extent required to finalize the long-term agreement between the Authority and the WeCare Denali, LLC; and

**WHEREAS,** because the parties have not yet finalized a long-term operations agreement for the Facilities or a long-term bulk purchase agreement, the Interim Operations Agreement and the Interim Bulk Purchase Agreement remain in effect; now therefore be it

**RESOLVED,** that the Board hereby acknowledges that because the parties continue to negotiate the long-term agreements, the Interim Operations Agreement and Interim Bulk Purchase Agreement remain in effect; and be it further

**RESOLVED,** that the Board hereby ratifies the term of the interim agreements executed by the parties and presented at this meeting.

Phillips: We are not creating new positions. Mr. Damiani can you explain what we are doing.

**Damiani:** I am looking to promote Ronnie Ludwig whom is currently our Solid Waste Operations Supervisor to Assistant Solid Waste Operations Manager. This is a position I held previously. Ronnie comes from the private sector and has over 35 years of experience. He has operated that facility for over 20 years under the contract of Joe Miele at the time as an employee. He is very knowledgeable within the industry. What I am asking for tonight is to promote him from Solid Waste Operations Supervisor to Assistant Solid Waste Operations Manager.

**Phillips:** With the overtime he is making now, he isn't really getting any additional pay. If anything, he is going to get less pay because it is the same amount of hours.

**Damiani:** He is obligated to fulfill the same requirements and make coverage as needed. A function that I was required to do regarding call outs over the weekend.

Phillips: Now we have somebody in management they can go to.

**Phillips:** The next number of resolutions we have talked about before. We have talked about what we are trying to accomplish within the Solid Waste Authority. We had numerous positions as laborers and a number of workers that were doing MEO I and MEO II functions. We wanted to come up with a scale.

This is relatable to what other municipalities are paying for these positions. This way we get an opportunity to treat our workers fairly and they know that there will be opportunity. Most importantly the decision to promote them will be left to the Executive Director so it is at our discretion to promote them up to these new positions.

Yeger: Are we abolishing then creating or are we getting new employees after.

**Phillips:** We are not getting any new employees we have a vacant laborers position which is on the agenda tonight. We are creating new positions, but we are not adding to the total number of employees.

**Yeger:** What are we doing with the positions that are being vacated. Are we abolishing them concurrently?

**WHEREAS,** the Rockland County Solid Waste Management Authority (the "Authority"), is a Public Authority Corporation duly organized and existing under Title 13-M of the Public Authorities Law of the State of New York; and

**Phillips:** We can leave them open until Personnel comes to us and says it's been open now for a while do you still want them. If we abolish them, it creates more work for us in the future then we would have to recreate a position. Most municipalities hang on to the positions when someone leave or goes somewhere else or retires then we have the basic position to hire somebody new when we move everybody up.
