2. Contractor Questions

Following issuance of this RFP, the Proposers may submit written questions to Rockland Green to assist the Proposers in the preparation of their Proposals. Rockland Green may, but shall not be obligated to, respond to such questions. All responses to any questions and requests for additional information which Rockland Green determines to be deserving of response will be issued to all potential Proposers of record in the form of addenda to this RFP which will be issued via email. The last day for submission of written questions have been extended from May 15 to June 6. Any questions submitted after the deadline for questions may be answered by Rockland Green at its discretion.

8. Addendum Number 1 state "… Rockland Green has decided to exercise this discretion and hereby waives the mandatory site visit meeting requirement for this RFP." Please confirm that the prebid was not mandatory and we can bid. A new site visit is scheduled. We recommend all proposers to attend the May 21st meeting to discuss the scope and address questions. As per Addendum 1, Rockland Green reserves the right to waive the mandatory meeting requirement.

The K-13 acoustical spray will be applied at a thickness of 1 inch, with a white finish in the exhibit and lobby areas and a black finish in the theatre.
